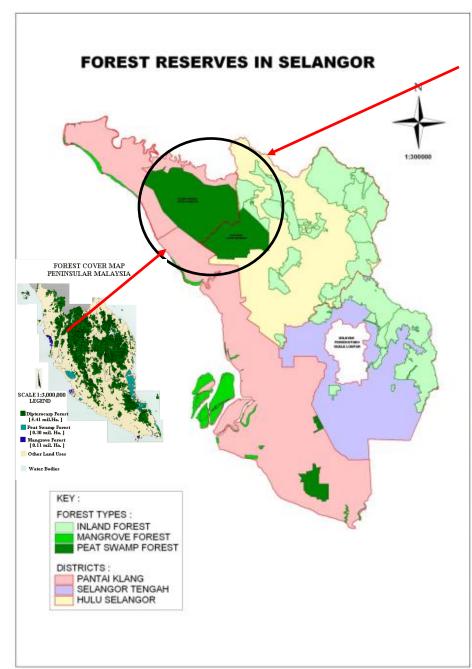


PROJECT BACKGROUND

PROJECT TITLE:

Rehabilitation and Sustainable Use of Peatland Forests in South East Asia – Malaysia Component

The sustainable use and rehabilitation of degraded peatlands in Malaysia will be emphasized under the project, particularly in the State of Selangor through capacity building, fire prevention and control, private sector partnership and demonstration of best management practices.
